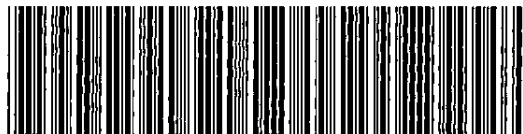



**ARTICLES OF INCORPORATION
for
Griffin Pride Athletic Club, Inc.**

Article I.

The name of the organization is Griffin Pride Athletic Club, Inc.

Article II.

The principal mailing address of the organization, Griffin Pride Athletic Club, Inc., is 650 Rantoul Lane, Lake Mary, FL 32746.

Article III.

The organization, Griffin Pride Athletic Club, Inc., is a not for profit organization. It will serve as the Booster Club and governing entity for the Football Program at an educational institution (Lake Mary Preparatory School) to benefit student-athletes. The organization, Griffin Pride Athletic Club, Inc., will have members. The organization is organized exclusively for charitable and educational purposes. Upon the dissolution of the organization, Griffin Pride Athletic Club, Inc., assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization of organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article IV.

The manner in which the Directors are elected or appointed is as follows:

1. In the first year of organization, the Directors are appointed by the Head Football Coach of the Athletic Department.
2. At the completion of the first year, subsequent Directors will be elected by a selection committee and/or vote.


