The name of the corporation shall be "Pr 22:6 Resource Ministry, Inc." a not-for profit corporation.

The principal office is 11250 Old St. Augustine Rd suite 15236 Jacksonville, FL 32257

The purpose for which the corporation is organized is to establish structured, consistent Children's Ministry programming (education) for the Dominican Republic Churches (and other Latin American churches as opportunities arise) leading children to learn to serve within the local church and grow future leaders.

The corporation will strengthen church leaders in the training of their youth from which future leaders will evolve. In the words of a veteran Dominican Christian Church leader, "If we don't train our youth to be leaders, our churches will die". Dominican Christian Churches are shrinking and the reversal of this trend is rooted in training the next generation.

Corporation activities will include but not be limited to:

- 1. Provide curriculum in Spanish (translating and adapting to cultural needs and limitations of the local churches)
- 2. Provide resources and supplies
- 3. Equip youth leaders
- 4. Organize Cross Cultural Mission's activities (trips) for partnering churches in the United States to witness, participate and share in equipping the next generation

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. "Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation."

Upon the dissolution of the corporation, assets shall be distributed to Swiss Cove Christian Church, an exempt 501 (c) (3) corporation, or other similar organization with exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code.

The initial Directors will be appointed by the Incorporator. Subsequent Directors will be nominated by existing Directors and approved by a majority vote of the Board of Directors. Vacancies will be filled in similar matter at the discretion of the Board of Directors. The minimum number of Directors is 5; there is no other restriction beyond this requirement.
