Attachment to Articles of Incorporation of Happy Plus Foundation Inc.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code. This Corporation shall be a nonprofit corporation. The specific purpose for which this corporation is organized is to help the after care journey of burn survivors and others with traumatic scarring through therapeutic massage and other alternative therapies. Our goals are simple: 1. Provide aftercare alternatives for burn survivors and others with traumatic scarring. 2. Teach self care to survivors and families. 3. Introduce survivors to massage therapy through outreach programs. 4. Provide Scar aftercare clinics for survivors. 5. Teach other massage therapists how to care safely and confidently for the traumatic scar community.

Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose.
