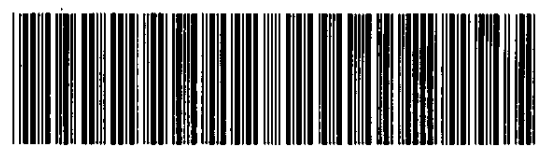

Article III - The organization is to operate for the exclusive purpose of accepting contributions from the general public, qualifying grants from other public charities and to promote charitable events such as golf tournaments to raise funds in order to provide wounded veterans with the equipment and the opportunity to play golf at three-hole training facilities, built adjacent to existing golf courses on military bases. The training facilities are designed to assist in the veterans' rehabilitation, lessening the burden of government.

Article VIII - Dissolution

The assets of Warriors on the Green, Inc. are permanently dedicated for this purpose and related qualifying exempt purposes within the meaning of section 501(c)(3). Upon dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.


