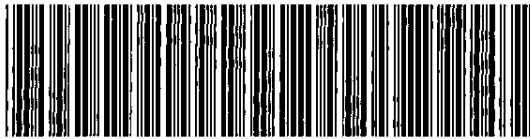


ARTICLE VIII DISSOLUTION OF ASSETS
