In Compliance with the requirements of the laws of the State of Florida, the undersigned hereby associate themselves together for the purpose of forming a corporation not for profit under Chapter 617, Florida Statutes, 1991, as amended, and do hereby certify:

ARTICLE I Name and Address

The name of the Corporation shall be All Nations Outreach Ministry, Inc., hereinafter called "All Nations" and whose address is 1532 Long Bay Road, Middleburg, FL 32068.

ARTICLE II Registered Agent and Incorporator

The name of the Registered Agent and Incorporator is Kenneth O. Pledger and the Corporation's Registered Office is 1532 Long Bay Road, Middleburg, FL 32068.

ARTICLE III Purpose

The purpose for which this corporation is organized is to provide charitable faith-based humanitarian aid to all nations. Such aid shall include, but not be limited to, establishing schools, medical and health care clinics, orphanages, churches, educational and vocational facilities and training, agricultural development, and in addition, strengthen local government infrastructure in such areas as construction, plumbing, electrical, sanitation, logistics, and housing.
