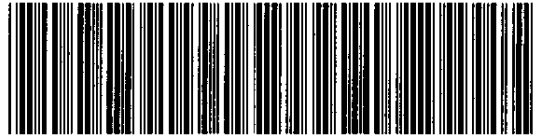



ONE: The name and address of this principal corporation is Order of Excellence Academy of the Arts, Inc. at 190 NE 35th Court, Oakland Park, FL 33334, in Broward County and the mailing address is P.O. Box 23051 Ft. Lauderdale, FL 33307. The Corporation is organized pursuant to the FLORIDA Non-profit Corporation Code.

TWO: The purposes for which the corporation is formed are as follows: Youth Mentoring, Conferences, Workshops/Seminars, Dance and Referrals to aid those in need of services outside of the boundaries of Order of Excellence Academy of the Arts.

THREE: The duration of this Corporation shall be perpetual, with no stock and shall have no members.

- FIVE:* (1) This organization is organized exclusively for charitable, religious, educational, and scientific purposes under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- (2) Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code or (2) by corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.
- (3) Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local organization, for public purposes.

SIX: The Directors are elected in accordance with the By-laws. The name and address of the persons appointed to act as the initial Directors of this Corporation are:


