

**ARTICLES OF INCORPORATION
OF
IGLESIA CRISTIANA CAMINO AL YO SOY
EL QUE SOY M.I., INC.
A
NOT FOR PROFIT CORPORATION**

These Articles of Incorporation are made and effective February 8, 2010.

The undersigned, acting as incorporator of a corporation under the Not for Profit Corporation Act of the State of Florida, in compliance with Chapter 617, F.S., adopt the following articles of incorporation for such corporation:

1. NAME OF THE CORPORATION

The name of the corporation, hereinafter referred to as the "Corporation" is
Iglesia Cristiana Camino Al Yo Soy El Que Soy M.I., Inc.

2. PERIOD OF DURATION

The period of duration of the Corporation is perpetual.

3. PURPOSES OF THE CORPORATION

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, under section 501(c)(3)] of the Internal Revenue Code, or corresponding section of any future federal tax code, including for such purposes as the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3)] of the Internal Revenue Code, or corresponding section of any future federal tax code. The Corporation may receive and administer funds for scientific, religious, educational, and charitable purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code and to that end, the Corporation is empowered to hold any property, or any undivided interest therein, without limitation as to amount or value; to dispose of any such property and to invest, reinvest, or deal with the principal or the income in such manner as, in the judgment of the directors, will best promote the purposes of the Corporation, without limitation, except such limitations, if any, as may be contained in the instrument under which such property is received, these Articles of Incorporation, the By-Laws of the Corporation, or any applicable laws, to do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof, but not for the pecuniary profit or financial gain of its directors or officers except as permitted under the Not-for-Profit Corporation Law of the State of Florida.

4. EARNINGS

No part of the net earnings of the Corporation shall inure to the benefit of any member, trustee, officer of the Corporation, or any private individual, except that reasonable compensation may be paid for

services rendered to or for the Corporation affecting one or more of its purposes, and no member, trustee, officer of the Corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation.

5. DISSOLUTION

Upon the dissolution of the Corporation or the winding up of its affairs, the assets of the Corporation shall be distributed exclusively for one or more exempt purposes within the meaning of Section 501(c)(3)] of the Internal Revenue Code and its Regulations as they now exist or any corresponding section of any future federal tax code as they may be hereafter amended, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

6. QUALIFICATIONS FOR MEMBERS

The qualifications for members and the manner of their admissions shall be regulated by the By-laws.

7. PRINCIPAL OFFICE
