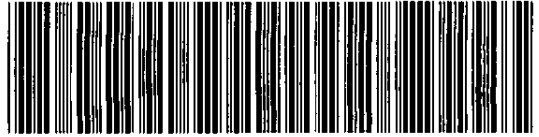

The Southern Cherokee Knights of the Golden Circle Incorporated is a Nonprofit Charity organization trying to help the Southern Cherokee Indian people better themselves Socially and economically and to help them preserve their culture and heritage. They are not State or Federally recognized as of the date of this filing. They receive no monies from any state or the Federal Government at this time as their part on the 1866 Treaty with the Cherokees on articles 1-8 have not been formally recognized or enforced at the present time.

When the Southern Cherokees are Formally - legally recognized as a tribe by State or Federal Recognition this non-profit organization shall dissolve - terminate itself and any funds existing in bank accounts at that time shall be sent to the legitimate Southern Cherokee Tribal government office.
