

**Broward Chamber of Nonprofit Organizations  
Amendment to Article III  
of the Articles of Incorporation**

**Article III**

The Broward Chamber of Nonprofit Organizations is organized under Chapter 617 of the Florida Statutes to preserve and strengthen a viable base of charitable Nonprofit Organizations providing health and human services in Broward County, Florida and all such other charitable purposes permitted to be carried out by not-for-profit Corporations under the laws of the State of Florida.

1. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
2. In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, state or local government for exclusive public use."
