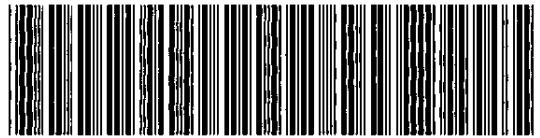

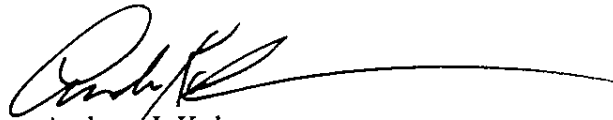

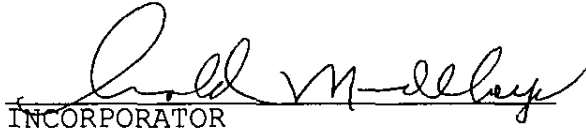
ARTICLE VI - CORPORATE OFFICE
