Articles of Incorporation of

Lawyers To The Resuce Corporation

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code. This Corporation shall be a nonprofit corporation. The specific purpose for which this corporation is organized is for lawyers dedicated to serving and providing support to individuals and families in the poorest communities.
