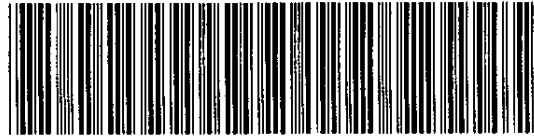

AMENDED ARTICLES OF INCORPORATION

The Articles of Incorporation of TTX Foundation, Inc., are hereby amended to restate the purpose of the corporation to be to acquire assets and distribute educational grants for student housing at the University of Florida, in conformance with Internal Revenue Code 501(c)(3), and any applicable federal and state laws and regulations promulgated thereunder.

The Articles of Incorporation of TTX Foundation, Inc., are hereby further amended to additionally provide that upon dissolution of this organization, its assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
