#### **ARTICLE VIII**

Said organization is organized exclusively for educational, training and community service purposes only.

### **ARTICLE IX**

No part of the net earning of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered distributions in furtherance of the purposes set forth in the purpose clause hereto. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in or intervene in any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c)(3) or the Internal Revenue Code, or corresponding section of any future 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

#### **ARTICLE X**
