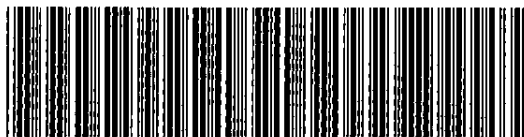

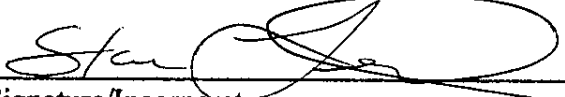

PURPOSE

Team Hooters Fastpitch Incorporated is organized exclusively for the charitable purpose of promoting amateur athletics within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as Section 501(c)(3) exempt organizations. To this end, Team Hooters Fastpitch Incorporated shall provide a competitive softball organization for young women to promote citizenship, sportsmanship, leadership, and good conduct. All funds, whether income or principal, and whether acquired by gift, contribution, or otherwise, shall be devoted to said purpose.
