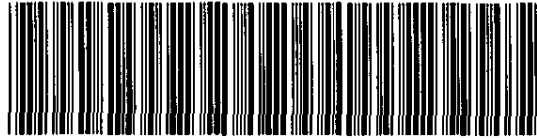

Articles of Incorporations
KC20/20Vision Ministries, Inc.

Articles of Incorporations of the undersigned, of which all are citizens of the United States, desiring to form a Nonprofit Corporation under the Laws of Florida, do hereby certify:

Article 1: The name shall be: KC20/20Vision Ministries Inc. *EFF. April 4, 2010*

Article 2: The Place in Florida where the principle office of KC20/20Vision Ministries Inc is to be located is the City of Tallahassee Florida, in the United States.

Article 3: KC20/20Vision Ministries Inc is organized for charitable, educational, religious, scientific purpose and other activities. KC20/20 Vision Ministries Inc. shall qualify as a 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future tax code. **The specific purpose of KC20/20Vision Ministries Inc shall be to Preach the Gospel to all that will hear it and initiate a neighborhood revitalization project that will include economic development through the creation of programs to promote business development. KC20/20Vision Ministries, Inc shall implement rehabilitation programs for housing in areas throughout Florida, the United States, and overseas. KC20/20Vision Ministries Inc. will establish job training components to help stabilize communities. In addition, KC20/20Vision Ministries Inc, shall provide tutorial assistants to neighboring students, establish mission trips to underdeveloped countries, provide a mentor program for at-risk children, establish a program to assist individuals re-entering the community from the Department of Corrections to include juveniles. KC20/20Vision Ministries Inc, will also provide HIV/Aids testing, establish an abstinence program for teens, provide health seminars, establish outreach programs to help individuals cope with various addictions, and will provide day care for adults and children. KC20/20Vision Ministries Inc will also provide additional programs approved by the Board of Directors.**

Article 4: KC20/20 Vision Ministries Inc shall have 3 directors, the director's names and addresses are: Mode of election or appointment of directors is found in the bylaws. To be named

Article 5: No part of the net earnings of KC2020Vision Ministries, Inc, shall insure to the benefit of or be distributed to its members or other private persons, except that KC2020Vision Ministries Inc, shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments for lease or rental equipment and distribution in furtherance of the purpose set forth in Article 3 hereof. No substantial part of the activities of KC2020Vision Ministries Inc, shall be the carrying on of propaganda, or otherwise attempting to influence legislation and KC2020Vision Ministries Inc, shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaigns on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, KC2020Vision Ministries Inc, shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purpose of KC2020Vision Ministries Inc.

Article 6: Upon the dissolution of KC2020Vision Ministries Inc, assets shall be distributed for one or more exempt purpose within the meaning of Section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to the State of Florida or local governments for a public purpose. Any such assets not so disposed shall be disposed of by a Court of Competent Jurisdiction of the Tallahassee, Florida in which the principal office of KC2020Vision Inc is located, exclusively for such purpose or to such organization, as said Court shall determine which are operated exclusively for such purpose.

Article 7: The registered agent and registered office of KC2020Vision Ministries Inc is:
