## Articles of Amendment Utesco Inc.

The name of this corporation is Utesco, Inc. The file number issued to the filing entity by the Secretary of State is: N10000002449. The date of formation of the entity is March 3, 2010.

The amendments are as follows:

### **Please Amend Article (THREE) to read as follows:**

The specific purpose for which the corporation is organized is to train and certify ministers in the arts of interpreting the Bible, ecclesiastical ceremonies, pastoral practices, and the operation of an evangelical church. Ordaining ministers of the Gospel. Provide administrative and spiritual supervision and direction for other organizations that will operate exclusively for educational, charitable and / or religious purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 and will voluntarily associate with this organization and to also participate in activities that are necessary, adequate or convenient for the achievement of that purpose, or that are incidental or related to the same and that are consistent with Section 501 (c) (3) of the Internal Revenue Code. This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501 (c) (3), Internal Revenue Code.

### **Please Add Article (EIGHT) to read as follows: Dissolution.**

In the event of dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**Non-Profit Organization.** No part of the net earnings of the corporation shall ever inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 4. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these Articles, this corporation will not carry on any

other activities not permitted to be carried on by (i) a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law, or (ii) a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1986 or any other corresponding provision of any future United States Internal Revenue law.
