



ARTICLE III- PURPOSE

1. The organizational purpose of Dimar Foundation, Inc. is to provide school supplies to Kwakwani Primary School and Kwakwani Secondary school which are located in the country of Guiana. We will also provide college scholarships to students with Guiana ancestry.
2. No substantial part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.
3. The Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as an exempt organization under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
