Articles of Incorporation Of John Taylor Ministries, Inc.

Article 1.

The name of the corporation is John Taylor Ministries, Inc.

Article 2.

The initial registered office of the Corporation shall be at 635 SE 10th Avenue, Cape Coral, FL 33990. The initial registered agent of the Corporation at such address shall be: John Taylor.

Article 3.

The Corporation shall not have Members.

Article 5.

Article 6.

The Corporation is organized exclusively for charitable, educational or religious purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended (the "Code") (or the corresponding provision of any future United States Internal Revenue Law), including, but not limited to the following:

To assist individuals in living a more Christian life style.

Article 7.

The Corporation shall have perpetual duration.

Article 8.

Any such assets not disposed of shall be disposed of by the Superior Court of the County in which the principal office of the Corporation is then located, to another organization as said the court shall determine, to be used in such a manner as in the judgment of the court will best accomplish the general purposes for which the dissolved organization was organized.

Article 10.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
