

Articles of Amendment to

### ARTICLES OF INCORPORATION OF FONDATION JEAN ROBERT CIUS, INC.

The undersigned, acting as incorporator of a corporation under the Not for Profit Corporation Act of the State of Florida, adopts the following articles of incorporation for such corporation:

#### **ARTICLE I- NAME**

The name of the corporation, hereinafter referred to as "FJRC" shall be:

FONDATION JEAN ROBERT CIUS, INC.

#### ARTICLE II- LOCATION

The principal place of business address of FJRC is 4699 N State Road 7, Suite L2, Tamarac, FL 33319

The initial street address in the state of FLORIDA of the initial registered office of FJRC is 4550 NW 41<sup>st</sup> Place, Lauderdale Lakes, 33319, and the name of the initial registered agent at such address is Wismy Cius.

The mailing address of FJRC shall be the same as the initial incorporator's.

#### ARTICLE III- PURPOSES

Founded by Wismy Cius, FJRC is organized exclusively for charitable, educational and community development purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as Section 501(c)(3) exempt organizations. Thus, FJRC's mission shall be to foster a commitment to children, young people and adults that will promote pro-social friendships, strong personal and interpersonal skills, and reassert a sense of hope in the future in order to reverse and decrease poverty growth effectively in our community. FJRC believes that only through personal relationships can a sense of individual responsibility be reestablished that will give children, youth and adults the commitment to follow through on path to community involvement and development and assisting the underprivileged effectively with a sense of pride and accomplishment. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

#### **ARTICLE IV- TERRITORIES**

The territories in which the operations of FJRC are principally to be conducted are both the United State of America and Haiti and their territories and possessions, but the operations of FJRC shall not be limited to such territories.

#### **ARTICLE V- DURATION**

The period of duration of FJRC is perpetual.

#### **ARTICLE VI-LIMITATIONS**

Section 1 FJRC may receive and administer funds for educational, and charitable purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 and to that end, FJRC is empowered to hold any property, or any undivided interest therein, without limitation as to amount or value; to dispose of any such property and to invest, reinvest, or deal with the principal or the income in such manner as, in the judgment of the directors, will best promote the purposes of the organization, without limitation, except such limitations, if any, as may be contained in the instrument under which such property is received, these Articles of Incorporation, the By-Laws of FJRC, or any applicable laws, to do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof, but not for the pecuniary profit or financial gain of its directors or officers except as permitted under the Notfor-Profit Corporation Law.

Section 2 No part of the net earnings of FJRC shall inure to the benefit of any member, trustee, officer of FJRC, or any private individual, (except that reasonable compensation may be paid for services rendered to or for FJRC affecting one or more of its purposes), and no member, trustee, officer of FJRC, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the organization. No substantial part of the activities of FJRC shall be the carrying on of propaganda, or otherwise attempting, to influence legislation, and FJRC shall not participate in or intervene in, including the publication or distribution of statements, any political campaign on behalf of any candidate for public office.

#### **ARTICLE VI- DIRECTORS / MEMBERS**

FJRC shall have a voting membership, and may have classes of same, as defined in FJRC's bylaws. The management and affairs of FJRC shall be at all times under the direction of a Board

of Directors, whose operations in governing FJRC shall be defined by statute and by FJRC's bylaws. No member or Director shall have any right, title, or interest in or to any property of FJRC.

#### ARTICLE IX- DISSOLUTION

Upon the dissolution of FJRC or the winding up of its affairs, FJRC's assets shall be distributed exclusively to one or more charitable, religious, scientific, testing for public safety, literary, or educational organizations which would then qualify under the provisions of Section 501(c) (3) of

the Internal Revenue Code and its Regulations as they now exist or as they may be hereafter amended, or to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of FJRC is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine which are organized and operated exclusively for such purposes.
