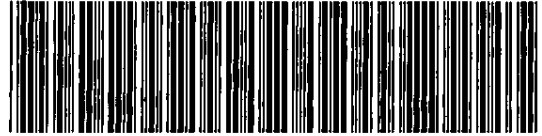

The undersigned subscribers to these Articles of Incorporation, being natural persons competent to contract, hereby form a corporation under and pursuant to the laws of the State of Florida providing for the formation, liability, rights, privileges and immunities of corporation for profit, and for that purpose, hereby certify, declare and set forth as follows, to wit:

ARTICLE 1

NAME OF THE CORPORATION

The name of the corporation shall be: MISSIONARY COMMUNITY SERVICE, INC.

ARTICLE II

PRINCIPLE OFFICE

ARTICLE III

GENERAL NATURE OF BUSINESS

SHARES OF STOCK
