Guiding Hands Early Learning Academy Inc. is organized for the purpose of education.

Accepting charitable contributions and donations that will be distributed throughout the facility to:

- A. Make childcare more affordable to all while following all state statutes, laws, and regulations pertaining to day care.
- B. Increase the quality of care by requiring all classroom teachers to have a bachelor's degree in education. Therefore they will be receiving an equivalent to a public school teacher salary. Increasing the quality of staff members will in turn increase the quality of education the children will receive.
- C. Provide a high quality learning environment. Funds, services, and goods will allow a constantly updated state of the art learning facility.

This organization and its' purpose qualifies as exempt under section 501 (c) (3) of the internal revenue code, or the corresponding section of any future tax code.

Guiding Hands' members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes stated. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Assets upon dissolution of the corporation shall be disbursed as vouchers to pay for day care, or in some form to benefit early childhood education exclusively for such purposes. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operate.
