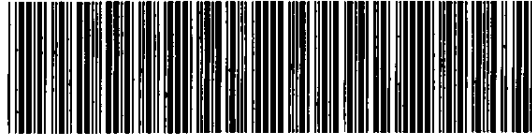

## *Narrative*

Malone Developmental Learning Center is a new arising learning center which will provide traditional/non-traditional education services to non-disable and disable children.
