ARTICLE I NAME

The name of the Corporation shall be: Zephyrhills High School Band Boosters Inc.

ARTICLE II PRINCIPAL OFFICE

The place in this state where the principal office of the Corporation is to be located is 6365 12th Street, Zephyrhills, Florida 33542 in Pasco County.

ARTICLE III PURPOSE
