Amendment: Adding Article IX

Upon the dissolution of the corporation, any assets remaining after paying or making provisions for the payment of all liabilities of the corporation shall be distributed to such organization or organizations organized and operated exclusively of charitable, education, religious, or scientific purposes which at the time of such disposition, qualify as an exempt organization or organizations under Section 501 (c) 3, Section 170 (c) 2, and Section 509 (a) 1 or 2 of the Internal Revenue Code of 1986 or corresponding sections of any future Internal Revenue Code by reason of such organization or organizations providing public services, or to the federal, state, or local government of exclusive public purpose. Any assets not so disposed of by a court of competent jurisdiction exclusively for such charitable purposes, or to such organizations organized and operated exclusively for such charitable purposes as said court shall determine.
