# Articles of Incorporation of Naples Park Jubilee, Inc.

In Compliance with Chapter 617, F.S., (Not for Profit)

## Article I. NAME

The name of the corporation shall be: NAPLES PARK JUBILEE, INC.

## Article II. PRINCIPLE OFFICE

The principal street address and mailing address, if different is: the address of the principle office of the corporation shall be 9696 Bonita Beach Rd. Suite 209, Bonita Springs, Florida 34135, and the mailing address of the corporation shall be P.O. Box 110324, Naples, Florida 34108.

## Article III. PURPOSES

The purpose for which the corporation is organized is: Naples Park Jubilee, Inc. will operate a not-for-profit corporation to serve those who need food assistance in the Naples Park area of Collier County. Assistance will be provided both to area residents and transients. This pantry will operate with assistance from individuals and organizations contributing both food and monies. In addition, events for the purpose of raising funds or food donations may be conducted by Naples Park Jubilee, Inc. These may include, but are not limited to, garage sales, operation of a thrift shop, etc. Any special events will be proposed and approved by the Board.

The corporation is organized exclusively for charitable, educational, religious, or scientific purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code.

Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
