ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

Concilio Casa de Adoración Internacional Inc.

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

The purpose of this organization is as follows:

- A. To establish and maintain an Office to promote the evangelism and preach the Gospel of our Lord Jesus Christ, according to our testimony; to assume our share of responsibility and privilege of propagating the Gospel by all available means, both locally and abroad.***
- B. To establish and affiliate Churches, Missions, Bible Institutes, and Seminary throughout the State and Worldwide, and provide for their mean and development. To have Radio Programs, Television Programs newspaper and magazine, and any other mean of communication.***
- C. To examine candidates for the Ministry and to License and Ordain as Ministers those candidates who shall meet the standards of the Scriptures and the Requirements as set forth in the Constitution and Bylaws of this Corporation.***
- D. To establish and maintain such sub-division, departments and Institutions as may be necessary for the propagation of the Gospel and the work of our churches, to be able to establish camp ground, retirement and Health Plan benefits for our ministers, and any other mean of helping our churches and ministers.***
- E. To elect its own officers and Committees, arrange for it's own meetings, Conventions and Seminars, and to govern itself.***

ARTICLE IV TERRITORY

The Concilio Casa de Adoración Internacional Inc. shall cover the State of Florida, other territories within the United States of America and Worldwide.

ARTICLE V PROPERTY

The Corporation shall have the power to buy, acquire and hold title in fee simple, in trust, or otherwise to both real and personal property. And improve, sell convey, and dispose of all such property, to borrow money, execute notes, bonds and other evidence of indebtedness and to secure the same by the mortgages and deeds of trust, annuity bond, and other instruments of indebtedness and to pay interest there on, to improve adapt and use property held by it for: the Concilio Casa de Adoración Internacional Inc. or it's successor without financial profit to it's members, except as may be necessary in the payment of salaries or other compensation for services rendered, and the Corporation shall have the power to erect and maintain buildings to be utilized by said Corporation, for the Worship of God, for the training in Christian Faith, and to build and maintain residences for the use of Ministers of: Concilio Casa de Adoración Internacional Inc. in conformity with the bylaws of said corporation and all the power and right granted to Corporations Not for Profit under the laws of the State of Florida.

ARTICLE VI MEMBERSHIP

The members of the Corporation shall be; All members in Good Standing at any given time of the Concilio Casa de Adoración Internacional Inc. provided however, neither the incorporators nor the members of the Corporation shall have any vested right, interest, or privilege of, in or to the assets, functions, affairs or franchises of this Corporation, or any right, interest or privilege which may be inheritable or shall continue after his membership ceases in the forenamed corporation. This corporation shall not have the power to buy, mortgage, sell, encumber or deed or dispose of any property which it may acquire, Without the consent of the direction of a two thirds (2/3) majority vote of the members of this corporation, or it's successor.

ARTICLE VII TERM

This Corporation shall exist perpetually or until dissolved by due process of the law.

ARTICLE VIII AMMENDMENTS

These articles of Incorporation may be amended in the manner provided by law. Every amendment must be first approved by the Official Board of Directors, (Trustees) then approved by a duly constituted meeting called for, two weeks in advance, by the members, by a majority of those entitled to vote thereon.

ARTICLE IX OFFICERS

The officers who are to manage this corporation shall be as follows: A President, A Vice-President, a Secretary, a Treasury and 2 elders, which 6 officers shall be the Trustees of the Corporation, and such officers shall be provided for in the bylaws, all of whom shall constitute and be the Official Board of Directors. They shall be elected from time to time in accordance with the bylaws, and each shall hold office until his (her) successor is elected and qualified, at it's regular annual meeting. The president shall sign in and the Secretary shall attest all legal contracts authorized by the members of this Corporation and the laws of the State of Florida.
