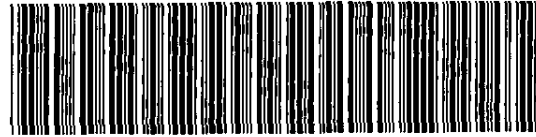

**ARTICLES OF INCORPORATION**

**ARTICLE I.** The name of this not for profit legal entity shall be the **BASKETBALL BROTHERS , INCORPORATED.** These Articles are filed pursuant to chapter 617.0202, Florida Statutes. The organization is organized exclusively for charitable , religious, educational, and / or scientific purposes under Internal Revenue Code section 501 ( c ) ( 3 ) or corresponding section of any future federal tax code.

**ARTICLE II.** The initial principal place of business shall be 250 North Orange Avenue, Suite 550, Orlando, Florida 32802.

**ARTICLE III.** The purpose of the organization is to promote amateur sports and to particularly promote education through athletics. Basketball is the primary focus of the organization, but other sports will be added throughout the development of this organization.

**ARTICLE IV.** The initial Director shall be appointed by the incorporator and they Shall be Dwayne L. Donnell, Robert Moramarco, Jari R. Philson, , and Dean Mosley. Additional Directors Shall be appointed by majority vote of initial directors, but not to exceed two. The Initial Board of directors shall not exceed five members. After the first year of Existence the board can increase its size by two third votes.

**ARTICLE V.** The chairman of the board of directors is Robert Moramarco, whose address is 3411 Southeast 29<sup>th</sup> Boulevard, Gainesville, Florida 32641. The

**chairman of the board, also Known as C.E.O shall set policy for the corporation concerning basketball tournaments and camps.**

**The CEO is the designated to Interface with general public, unless he designates another board member. Dwayne L. Donnell shall serve as treasurer and his address is 320 N. 14<sup>th</sup> Avenue, cape Coral, Fl 33909. Jari Philson whose address is 7488 Bristol Circle, Naples, Fl. 34120. Dean Mosley will serve as a board member and legal adviser, however shall not be responsible for handling litigation for the corporation. The Secretary and Legal adviser shall assist the corporation with all legal issues and maintain a record Of corporate meetings. If legal issues require litigation then outside counsel will be Obtained to avoid any conflict of interest. No board member shall vote in any Meeting to generate business for himself.**

**ARTICLE VI. The initial registered agent is Dean F. Mosley, and his address is 250 N. Orange Avenue, Suite 550 Orlando, Florida 32801.**

**ARTICLE VII. The name of the incorporator is Dean F. Mosley and his address is 14408 Salinger Road, Orlando, Florida 32828.**

**ARTICLE VIII. That all teams playing in tournaments or camps sponsored by this corporation will be racially inclusive. There will be no discrimination based on race. There will be boys and girls tournaments held throughout the year.**

**ARTICLE IX. The treasurer will set guidelines for centralizing fundraising Activities.**

**ARTICLE X. The team coaches will sign contracts with the Basketball Brothers ,**

**V Inc. and submit proof that they have undergone a criminal background check.**

**ARTICLE XI. The corporation will pursue college educational and athletic**

**Scholarships for the youth athletes by showcasing their talents in basketball and Academics.**

**ARTICLE XII. The corporation has agreed that upon dissolution of the**

**Corporation, all remaining assets will be distributed for one or more exempt purposes within the meaning of the Internal Revenue Code section 501 ( c ) ( 3 ), or corresponding section of any future federal tax code, or will be distributed to the federal government , or tot a state of local government for a public purpose.**

**ARTICLE XIII. The board of directors agrees that no board member will vote on issues that serve to benefit that individual board member financially. The board of directors shall always avoid the conflict of interest when a vote serves to benefit aboard member personally.**

**ARTICLE XIV. The members of this organization will pay a membership fee or annual dues that Shall be established by the board of directors. The membership fee will not be based on any racial criteria. This corporation shall not use race as any criteria for membership. Athletes of all ethnic groups and racial groups are invited to compete in our programs. Participation in our programs is based on athletic ability. The teams are comprised of elite athletes.**
