Pursuant to the provisions of Section 617.1403, Florida Statutes, this Florida corporation not for profit submits the following Articles of Dissolution:


1. The name of the corporation is 2012 Tampa Bay Host Committee, Inc. (the "Corporation").

The number of directors in office was six and the vote for resolution was six in favor and none against. No directors were absent.


