

Article 3 Purpose Please amend in its entirety to read:

The specific purpose for which the corporation is initially organized is to teach and preach the Gospel of Jesus Christ at every available venue, to be a faith based ministry that will feed, clothe, educate, provide shelter, and other practical support to the poor of the world, to establish and oversee places of worship, conduct the work of evangelism worldwide, create departments necessary to support missionary activities, to license, ordain and oversee ministers of the gospel, and to also engage in activities which are necessary, suitable or convenient for the accomplishment of that purpose, or which are incidental thereto or connected therewith which are consistent with Section 501(c)(3) of the Internal Revenue Code.
