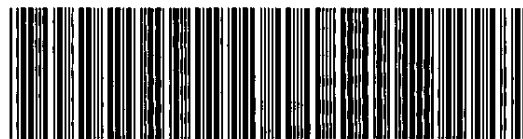

**Article 3 Purpose Please amend in its entirety to read:**
