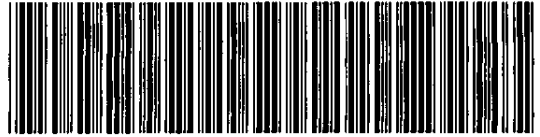

**ARTICLES OF INCORPORATION**  
**55PLUS SENIOR SERVICE INC.**

In compliance with Chapter 617, F.S., (Not for Profit)

**PREAMBLE**

The undersigned citizens of the United States, desiring to form a not for profit corporation under Chapter 617, Florida Statutes, certify and acknowledge the following:

**ARTICLE I – NAME**

The name of the Not for Profit Corporation shall be: "55Plus Senior Service, Incorporated". (hereinafter "Corporation").

**ARTICLE II – PRINCIPAL OFFICE**

The principal office and mailing address of the Corporation shall be 107 Spring Street, Altamonte Springs, FL 32701.

**ARTICLE III – PURPOSE**

The purpose for which the organization is organized is exclusively for charitable, educational and religious purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501c(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. More specifically we shall provide service to the elderly population.

**ARTICLE IV – MANNER OF ELECTION**

The directors of the Corporation shall be elected in accordance with the methods and qualifications specified in the bylaws of the Corporation. In no event, shall the number of directors be fewer than three.

#### **ARTICLE VIII – LIMITATIONS**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for service rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE IX – DISSOLUTION**

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for

such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
