ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

Article 1 - The name of the corporation shall be Osceola County Camera Club, Inc.,

Article 2 – The place in this state where the principal office of the Corporation is to be located is the City of St. Cloud, Osceola County. 4943 PAR いとい ひた、St. Cwa, エ 3477

Article 3 - Said corporation is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article 4 - The Initial Board, shall have a minimum of 3 Officers; President, Vice President and Secretary. This Initial Board shall serve for 2 years in order to establish the club, its activities and its nonprofit status. The initial Board may be reelected for unlimited terms. After the initial Board, the Board will be elected by the membership and the term of office will be for one year. Additional Directors may be appointed by the Board up to 6 additional Directors for positions as listed in the Corporations By - Laws, but the Board must always consist of an odd number.

Article 6 — No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

If reference to federal law in articles of incorporation imposes a limitation that is invalid in your state, you may wish to substitute the following for the last sentence of the preceding paragraph: "Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation."

Article 7 — Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
