



A teen inspired project to end teen violence. To create a cascading effect of social change in the current teen culture with the formation of various teen aged groups. The structure will be such that older teens (high school age) would then assist and mentor the younger teens (middle school age) mentor younger teens by talking about non-violent alternatives and live by example so that there is a change in the social acceptance of bullying and teen violence from older to younger.

The creation of teen seed groups within schools as an after school or off campus activist group. With the thrust of the mission guided by s student leaders, class leaders and concerned teens will be involved in creating definitive plans to delay or stop bullying and teen violence. Band Against Violence, Inc. will provide guidance information and instruction through written material, e mails, and postings on social networks and website on how to get more involved in their respective communities to affect change. This network of information will be passed on to gain more potential members and to grow the groups.

Professional leadership and guidance will come from professionals in the field of law enforcement, teen counselors, physiologists, psychiatrist and other social workers donating their time to share anti bullying and anti violence information/strategies etc...

Band Against Violence, Inc is an awareness program designed by teens for teens to end teen violence and bullying. Teens are the source of this problem and they must be the solution. They will be responsible for spreading the word and soliciting other teens to join the group for change. It is an organization with the sole purpose to bring awareness resulting in change. Literature and supportive paraphernalia such as t shirts, silicone wristbands, hats etc.. will be sold for revenue to support growth of the organization.
