ARTICLES OF INCORPORATION

The undersigned, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida, in Compliance with Chapter 617, F.S. do hereby certify:

ARTICLE I NAME

The name of the corporation shall be: **Free Trees and Plant Adoptions, Inc.**

ARTICLE III PURPOSE

The purpose for which the corporation is organized is: **The purpose of Free Trees and Plant Adoptions is to be a nonprofit, charitable organization that will give away free trees and plants. Directors shall be elected by the members of the organization at the Annual General Meeting of the Corporation, as provided for in the Bylaws.

ARTICLE VI INUREMENT OF INCOME

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE IX Dissolution

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the

corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
