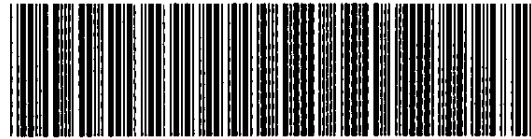

### **ARTICLE III PURPOSE**

will maintain communication with political prisoners through magazines, newspapers,  
phone calls and provide them with social services such as medical assistance, medicine,  
and referrals free of charge.
