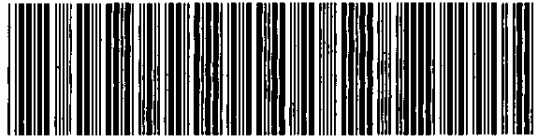

ARTICLES OF INCORPORATION
OF
PUNTA GORDA ISLES DUPLICATE BRIDGE CLUB,
A NON-PROFIT CORPORATION

ARTICLE I

The name of the corporation shall be PUNTA GORDA ISLES DUPLICATE BRIDGE CLUB, A NON-PROFIT CORPORATION.

ARTICLE II


