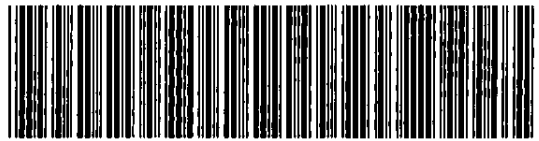



The undersigned, for the purpose of forming a Not-for-profit corporation under the laws of the state of Florida, do hereby adopt the following Articles of Incorporation.

ARTICLE I
NAME

The name of the corporation shall be **Children Safe At Grandma's Place, Inc.** (hereinafter called the "Corporation").

ARTICLE II

ARTICLE VII DISSOLUTION

No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislations (except as otherwise provided in subsection (h) of Section 501 (c) 3 of the Internal Revenue Code 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law), or (b) by a corporation, contributions to which are deductible under Section 170 (c) 2 of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law).
