

First Amendment to Articles of Incorporation of Friends of the Minneola Schoolhouse Library, Incorporated

Article II of the Articles of Incorporation is amended to read as follows:

Article II - Purpose and Powers

Paragraph two is amended to read as follows:

The Friends of the Minneola Schoolhouse Library, Incorporated is organized exclusively for charitable and educational purpose, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the Friends of the Minneola Schoolhouse Library, Incorporated, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not dispose of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
