ARTICLES OF INCORPORATION OF GROUNDSWELL COMMUNITY, INC. (A FLORIDA NOT-FOR-PROFIT CORPORATION)

Articles of Incorporation

The undersigned, a citizen of the United States, desiring to form a Corporation Not for Profit under the Corporation Not for Profit Law of Florida, Chapter 617, Florida Statutes, certifies and acknowledges:

ARTICLE I. NAME.

The name of the Corporation Not for Profit shall be Groundswell Community, Incorporated (the "Corporation").

ARTICLE II. PRINCIPAL OFFICE AND ADDRESS.

The initial principal office and mailing address of the Corporation is 1401 N. Randolph Circle, Tallahassee, FL 32308.

ARTICLE III. PURPOSES.

Section 1. IRC Section 501(C)(3) Purposes

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code.

Section 2. Specific Purposes

The specific purposes of the Corporation are:

- To create and evaluate demonstration projects, centers, programs, gatherings, etc. to model innovative sustainable and socially just living practices.
- To create timely and practical sustainable approaches to home-based energy and water conservation and efficiency, local food production and distribution, and an appreciation of the local natural environment and social history.
- To develop and provide education programs and events that teach innovative sustainable and socially just living practices and an appreciation and understanding of the local natural environment.
- To encourage people to live a more sustainable, self-reliant, and socially just lifestyle.
- To promote a sense of participation in and service to the broader, local community.
- To promote a more local and sustainable economy.

- To create diverse partnerships to fund projects that lead to choices/actions to reduce personal contributions to climate change, natural resource depletion, or environmental degradation and that prepare people to adjust to the changes that may accompany these conditions in practical, creative, cooperative, and just ways.
- To promote an understanding of global climate change, energy/natural resource depletion, and environmental degradation and their potential impacts on local, national, and worldwide levels.
- To do all things necessary to accomplish the purposes described above.

ARTICLE IV. ELECTION OF BOARD OF DIRECTORS.

The business affairs of this corporation shall be managed by the board of directors. This corporation will have 3 Directors initially, who shall hold office until their successors are chosen. The number of Directors may be increased or decreased from time to time as provided in the bylaws, but there shall never be fewer than three Directors. Directors shall be elected and hold office in accordance with the bylaws. Individuals are elected to the Board of Directors by a majority vote of the current Board of Directors.
