ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

A secure depository for dental records which can be utilized by Law Enforcement and other Authorized and Properly Vetted or Certified Agencies, Health Care Providers and/or Individuals for the purpose of identification and/or other forensic investigation or discovery as necessitated or indicated as an aid to or collaboration of the identification of human remains.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The President shall initially name and appoint the Directors until such time as there are at least five (5) individuals who have accepted the appointment and have served for a minimum of one (1) year, at which time a quorum of at least 60% of the tenured directors shall then be empowered to add or delete Directors, at a meeting to be held no less than once a year for this specific purpose and at no time shall the number of directors, by vote, be less than five (5). Loss of Directors other than by Vote below five (5) shall be the basis for a special election of Directors, with the President having the power of veto until at least five (5) permanent directors are in place.
