Articles of Incorporation of

S.E.D STRONGER EVERY DAY

SECRETARY OF STATE MALAHASSEE, FLORIDA

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code. This Corporation shall be a nonprofit corporation. The specific purpose for which this corporation is organized is to help women of all ages achieve the confidence and individuality that they are entitled to. In order to help this confidence grow, we offer ourselves as an escape from unhealthy relationships that hinder these women from completing their life goals and dreams.

Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose.
