In compliance with Chapter 617, Florida Statutes (Not for Profit), the undersigned, all of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

**ARTICLE I- NAME:** The name of the Corporation shall be Sarasota Youth Sports Training and Educational Mentorship, Inc..

**ARTICLE II- PRINCIPAL OFFICE :** The principal place of business and mailing address of the corporation is 301 South School Avenue, Sarasota, Florida, 34237.

**ARTICLE III- PURPOSE:** The Corporation is organized exclusively for charitable and educational purposes, to provide a facility and setting where student athletes and the youth in the community will be taught, challenged, supported and inspired to train for optimal performance in sports and physical fitness with an emphasis on mental awareness education; including such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE IV-INITIAL DIRECTORS:** The names and addresses of the persons who are the initial directors of the corporation are as follows:

**ARTICLE V-MANNER OF ELECTION:** The manner in which the directors shall be elected will be set forth in the Bylaws of the corporation and shall be held on an annual basis.

**ARTICLE VI – INITIAL REGISTERED AGENT:** The name and street address of the initial registered agent is Jason Marien, 4026 Lancaster Drive, Sarasota, Florida 34241.

**ARTICLE VII – EARNINGS :** No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax


code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE VIII - DISSOLUTION:** Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Circuit Court in and for Sarasota County, Florida, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.



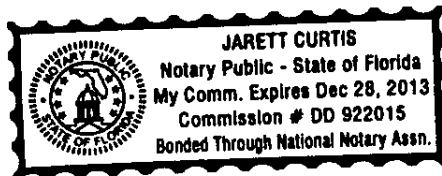
