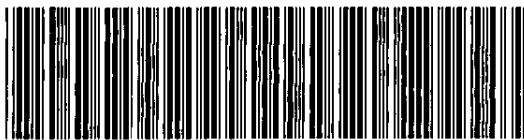

**ARTICLE OF INCORPORATION  
OF**

**PATSY & ANTHONY DESTINY FOUNDATION, INC.**  
A Florida Not for Profit Corporation

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I - NAME**

The name of the corporation is the Patsy & Anthony Destiny Foundation, INC.

**ARTICLE II - PRINCIPAL OFFICE**

1740 NW 127<sup>th</sup> St  
Miami, FL 33167

The principle office of the corporation shall be fixed and located at such a place within the State of Florida, as the Board of Directors shall determine. The Board of Directors is granted full power and authority to change said principle office from one location to another within the State of Florida.

**ARTICLE III - PURPOSE**

a) **General Purpose.** The corporation is organized exclusively for one or more of the charitable, educational, and scientific purposes specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code.

b) **Specific Purpose.** The specific purpose of the corporation shall be to feed, clothe, and provide other social services to the poor, disadvantaged, in and at risk populations locally and internationally by; i) partnering with governmental and nongovernmental organizations and individuals to unlock the human potential of the underserved, the poor, and the disadvantaged; ii) provide direct programs, projects and assistance in partnership with organizations and individuals both domestic and foreign.

**ARTICLE IV - TERM**

The corporation shall have a perpetual existence.

**ARTICLE V - INCORPORATOR**

The name and address of the incorporator of these Articles of Incorporation is: Patricia Hughes, 1740 NW 127<sup>th</sup> St Miami, FL 33167

**ARTICLES VI - MANAGEMENT**

The authority of all affairs of the Corporation shall be in a Board of Directors consisting of at least (3) directors who shall and may exercise all the powers of the Corporation as permitted by federal law,



state law, these Articles of Incorporation, and the Bylaws of the Corporation as from time to time in effect.

The members of the Board of Directors shall be elected or appointed pursuant to the method set forth in the Bylaws of the Corporation. The first Board of Directors shall be (4) in number, and their names and address being as follows:

**Elective Officers.** The Officers of the Corporation shall be a president, secretary and treasurer. Other offices and officers may be established or appointed by members of the Corporations at any meeting of the Board of Directors. The qualifications, the time and manner of electing or appointing, the duties of, the terms of the office and the manner of removing officers shall be set forth in the bylaws.

The officers who are to serve until the first election of officers under these Articles of Incorporation are:

President, Patricia Hughes  
Vice-President, Bernadette Andrews  
Treasurer, Claudette Randall  
Secretary, Winston Hughes

#### **ARTICLE VII – LOCATION AND IDENTIFICATION OF REGISTERED AGENT**

The address of the Corporation's initial registered office in the State of Florida is: 1740 NW 127<sup>th</sup> St Miami, FL 33167 and the name of the Corporation's initial registered agent is Patricia Hughes located at the address above.

#### **ARTICLES VIII – EARNING AND ACTIVITIES OF CORPORATION**

- (a) No part of net earnings of the Corporation shall inure to the benefit of, or be distributable to its directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purposes set forth in these Articles of Incorporations.

- (b) No substantial part of the activities of the Corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
- (c) Notwithstanding any other provision of these Articles of Incorporation, the Corporation shall not carry on any other activities not permitted to be carried on (i) by a corporation exempt from Federal income tax under Section 501 (c)(3) of the Internal Revenue Code, (ii) by a corporation, contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code or (iii) by a not for profit corporation organized under the laws of the State of Florida.
- (d) Notwithstanding any other provision of these Articles, the Corporations shall not except to any insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of the Corporation.

ARTICLE IX – INDEMNIFICATION

The Corporation shall indemnify, to the fullest extent allowed by law, any person who was or is a party, or is threatened to be made a party, to any threatened, pending or contemplated action, suit or proceeding, whether civil, criminal, administrative or investigative (other than an action by or in the name of the Corporation) by reason of the fact that he or she is or was a director, employee, officer or agent of the Corporation.

ARTICLE X – BYLAWS

Bylaws will be hereinafter adopted at the first meeting of the Board of Directors. Such bylaws may be amended or repealed, in whole or in part, by the Board of Directors in the manner provided therein. Any amendments to the bylaws shall be binding on the Corporation.

ARTICLE XI – AMENDMENT OF ARTICLES

Amendments to these Articles of Incorporation may be made by a resolution adopted by the Board of Directors.

ARTICLES XII - DISSOLUTION

The corporation and its affairs shall be dissolved by a two-thirds vote of the Board of Directors. Upon dissolution of the Corporation, the Board of Directors shall after paying or making provision for the payment of all the liabilities of the Corporation, dispose of all of the assets of the Corporation exclusively for the purpose of the Corporation in such a manner, or to such organization or organizations organized and operated exclusively for charitable or educational purposes as shall at the time qualify as an exempt organization or organizations under Section 501 (c)(3) of the Internal Revenue Code of 1954 as the Board of the Directors shall determine. Any such assets not so disposed of by a Court of competent jurisdiction in the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organizations or organizations as such Court shall determine, which are organized and operated exclusively for such purposes.

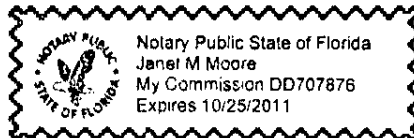
