ARTICLES OF INCORPORATION

OF

SOYC, INC.
(A Not for Profit Corporation)

ARTICLE I NAME

The name of the Corporation shall be SOYC, INC. (hereinafter referred to as the "Corporation"). Its principal office shall be located at 8811 Highway A1A., Vero Beach, Indian River County, Florida 32963, or at such other place as may be designated, from time to time, by the Board of Directors.

ARTICLE II DURATION

The period of duration of the Corporation is perpetual.

ARTICLE III PURPOSE AND POWERS

The corporation is organized exclusively for the purpose of operating a yacht club within the Sea Oaks community in Vero Beach, Florida.

ARTICLE IV PROHIBITION AGAINST DISTRIBUTION OF INCOME

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II, above.

ARTICLE V CAPITAL STOCK

The Corporation shall have no capital stock and shall be composed of members rather than shareholders.

ARTICLE VI QUALIFICATIONS OF MEMBERSHIP

The categories of membership, qualifications for membership and the manner of admission shall be as set forth in and regulated by the By-Laws of the Corporation.

ARTICLE VII VOTING RIGHTS

Members of the Corporation will have such voting rights as are provided in the By-Laws of the Corporation.

ARTICLE VIII LIABILITY FOR DEBTS

Neither the members nor the officers or directors of the Corporation shall be liable for debts of the Corporation.

ARTICLE IX BOARD OF DIRECTORS

The Corporation's initial Board of Directors shall be composed of nine (9) members. The method of election of directors, as well as the method for increasing or decreasing the number of the Board, shall

ARTICLE XII DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed in accordance with the provisions of Chapter 617 F.S. or as stated in the By-Laws. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then

located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
