The undersigned for the purpose of forming a not-for-profit corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be **New Faith Community Development Corporation, Inc.** (hereinalth called the "Corporation").

ARTICLE II PRINCIPLE OFFICE AND MAILING ADDRESS

The principle office and mailing address of the Corporation is 6550 Adriatic Way, West Palm Beach, Florida 33414.

ARTICLE III PURPOSE

The specific purpose of this not-for-profit corporation is for the charitable, religious and educational training purposes in Section 501 (c) of the Internal Revenue Code 1986 and for the purpose of engaging in any lawful act or activity not for pecuniary profit for which not for profit corporation may be organized, so far as is or may be permitted by law of the State of Florida and Section 501 (c) 3 of the Internal Revenue Code 1986 as amended New Faith Community Development Corporation, Inc. ARTICLE IV MEMBERSHIP

Any person, relative, corporation, partnership, association or organization who is interested in the purpose of the Corporation, who is capable of contributing to the achievement of those purposes and the effective operation of the Corporation, and who complies with the requirements established from time to time by the By-laws, shall be eligible for membership.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislations (except as otherwise provided in subsection (h) of Section 501 (c) 3 of the Internal Revenue Code 1986, as amended, and the Corporation shall not participate of intervene in (including the publishing or distribution of statement) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (c) 3 of the Internal Revenue Code 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law), or (b) by a corporation, contributions to which are deductible under Section 170 (c) 2 of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United Stated Internal Revenue Law).
