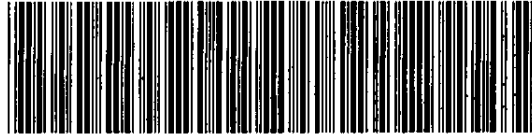

Article I *Name:* The name of the corporation shall be Kingdom Generation Ministries Inc.
