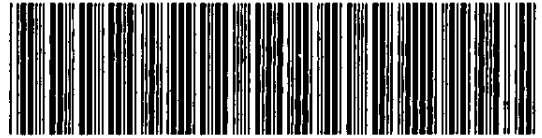

The undersigned incorporator, for the purpose of forming a Florida Not-For-Profit corporation, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is:

ARTICLE III

The purpose for which this corporation is organized is:

Kids In Harmony, Inc., is organized exclusively for charitable purposes within the meaning of section 501(c)3 of the Internal Revenue Code; and to engage in any lawful purpose under the Not For Profit Corporation Act, and to distribute the whole or any part of the income therefrom and the principal thereof exclusively for charitable, scientific, literary, educational, or fostering national or international amateur sports purposes, either directly or by contributions to organizations that qualify as an exempt organization under Section 501(c)3 of the Internal Revenue Code (the "Code") of 1986 and Regulations issued pursuant thereto, as they now exist or as they may hereafter be amended.

Kids In Harmony, Inc., is not a private foundation as defined under Section 509 of the Code, and shall receive a substantial part of its support directly or indirectly from contributions from the public.

Notwithstanding any other provisions of these Articles, the corporation shall not carry on

any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)3 of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue Law), or (b) by a corporation contributions to which are deductible under section 170(c)2 of the Internal Revenue Code or 1986 (or the corresponding provision of any future United States Revenue Law).

#### ARTICLE IV

The manner in which directors are elected or appointed is:

Each person named in the Articles of Incorporation or elected at the Initial Meeting of Incorporators as a member of the initial board of directors will hold office until said directors will have been qualified and elected at the first annual meeting of members, or until said directors' resignation, removal from office or death.

#### ARTICLE VI

The manner in which earnings are handled by the corporation is:

No part of the net earnings of Kids In Harmony, Inc., shall inure to the benefit of or be distributed to any Directors or Officers of the corporation, and no Director or Officer of Kids In Harmony, Inc., or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation. Kids In Harmony, Inc., may pay compensation in a reasonable amount to its Members, Directors, or Officers for services rendered in conformity with its purpose. Any such payment does not constitute distribution of income or profit.

ARTICLE VII

The manner in which distribution of assets upon dissolution is handled is:

Upon winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a non-profit fund, foundation, or corporation which is organized and operated exclusively for charitable, educational, religious, and/or scientific purposes and which has established its tax exempt status under section 501(c)3 of the Internal Revenue Code.
