## (Amended) Articles of Incorporation of Elma's Education Foundation Inc.

#### A Not for Profit Corporation

**Articles of Incorporation of** the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Public Benefit Corporation Law of Florida, do hereby certify:

I.

The name of the Corporation shall be Elma's Education Foundation Inc.

II.

The place in this state where the principal office of the Corporation is to be located is the 4944 SW 135<sup>th</sup> Ave Miramar, FL 33027.

III.

A. This corporation is a nonprofit PUBLIC BENEFIT CORPORATION and is not organized for the private gain of any person. It is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section

501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

B. The specific objectives and purposes of this corporation shall include but is not

limited to the provision of educational materials and school supplies to disadvantaged

children in Jamaica. Elma's Education Foundation's goal is to enhance learning.

The names and addresses of the persons who are the initial directors of the corporation

and this corporation's initial agent for service of process is:

IV.

Directors shall be elected by the board of directors, at any time, and each officer shall

hold office until he or she resigns or is removed or is otherwise disqualified to serve, or

until his or her successor shall be elected and qualified, whichever occurs first.

V.

A. This corporation is organized and operated exclusively for **charitable** purposes

within the meaning of Section 501(c) (3) of the Internal Revenue Code.

B. The property of this corporation is irrevocably dedicated to charitable purposes

and no part of the net earnings of the corporation shall inure to the benefit of, or be

distributable to its members, trustees, officers, or other private persons, except that the

corporation shall be authorized and empowered to pay reasonable compensation for

services rendered and to make payments and distributions in furtherance of the purposes

set forth in Article Third hereof. No substantial part of the activities of the corporation

shall be the carrying on of propaganda, or otherwise attempting to influence legislation,

and the corporation shall not participate in, or intervene in (including the publishing or

distribution of statements) any political campaign on behalf of or in opposition to any

candidate for public office. Notwithstanding any other provision of these articles, the

corporation shall not carry on any other activities not permitted to be carried on (a) by a

corporation exempt from federal income tax under section 501(c)(3) of the Internal

Revenue Code, or the corresponding section of any future federal tax code, or (b) by a

corporation, contributions to which are deductible under section 170(c)(2) of the Internal

Revenue Code, or the corresponding section of any future federal tax code.

Notwithstanding any other provision of these articles, this corporation shall not, except to

an insubstantial degree, engage in any activities or exercise any powers that are not in

furtherance of the purposes of this corporation.

VI.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
