

1. Name.

The name of the Corporation is **LNPG-CH Foundation, Inc.**

2. Principal Office and Registered Agent.

3. Purposes.

The nature of the business or purposes to be conducted or promoted is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of Florida. This Corporation is:

To serve, assist, reach-out to the community, build and manage resources, establish scholarship programs

To provide charitable services;

To manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, goods, wares, merchandise, real and personal property, and services, of every class, kind and description;

To conduct business, have one or more offices, and buy, hold, mortgage, sell, convey, including franchises, patents, copyrights, trademarks, and licenses, in the State of Florida and all other states and countries;

To contract debts and borrow money, and execute such mortgages, transfers or corporate property, or other instruments to insure the payment of corporate indebtedness as required;

4. Capital Stock.

The Corporation shall have no authority to issue stocks or bonds. There are no shareholders, but volunteer Directors in the corporation.

5. Incorporator.

The name and mailing address of the incorporator is: Jacques Registe, 8613 Heartwood Court, Tallahassee, Florida 32312.

6. Existence.

The Corporation is to have perpetual existence.

7. Liability of Directors

The private property of the directors shall not be subject to the payment of corporate debts.

9. Management.

Subject to the provisions of the laws of the State of Florida, the following provisions are adopted for the management of the business and for the conduct of the affairs of the Corporation, and for defining, limiting and regulating the powers of the Corporation, the directors:

- (a) The books of the Corporation may be kept outside of the State of Florida at such place or places as may from time to time be designated by the Board of Directors.
- (b) The business of the Corporation shall be managed by its Board of Directors; and the Board of Directors shall have power to exercise all the powers of the Corporation, including (but without limiting the generality hereof) the power to create mortgages upon the whole or any part of the property of the Corporation, real or personal, except as otherwise provided by statute or by the Bylaws.
- (c) An increase in the number of directors shall be deemed to create a vacancy or vacancies in the Board of Directors, to be filled in the manner provided in the Bylaws. Any director or any officer elected or appointed by the Board of Directors may be removed at any time, in such manner as shall be provided in the Bylaws.
- (d) The Board of Directors shall have power to make and alter the Bylaws.
- (e) The Board of Directors shall have the power, in its discretion, to fix, determine and vary, from time to time, the amount to be retained as surplus and the amount or amounts to be set apart out of any of the funds

of the Corporation available for dividends as working capital or a reserve or reserves for any proper purpose, and to abolish any such reserve in the manner in which it was created.

(f) The Board of Directors shall have the power, in its discretion, from time to time, to determine whether and to what extent and at what times and places and under what conditions and regulations the books and accounts of the Corporation, or any of them, shall be open to the inspection of donors; and no donor shall have any right to inspect any account or book or document of the Corporation, except as conferred by law or authorized by resolution of the directors.

(g) The Corporation reserves the right to amend, alter, change, add to or repeal any provision contained in this Certificate of Incorporation in the manner now or hereafter prescribed by statute; and all rights herein conferred are granted subject to this reservation.


